LIFETIME GLASS BREAKAGE WARRANTY

This warranty is extended to the original single family homeowner/property owner ("owner") identified in this warranty certificate ("Certificate") and the attached Warranty Registration Card, by Superior Metal Products LLC. Subject to the terms and conditions put forth in this certificate, Superior Metal Products LLC makes the following warranties to you, the original single family homeowner, regarding the insulated glass panels of the vinyl replacement window(s) installed on the property identified in this certificate and Warranty Registration Card. Coverage is limited to the original homeowner as long as you live and own the property at the address listed herein and is not transferable.

If a panel of insulated glass manufactured by Superior Metal Products LLC and installed in one of its vinyl replacement windows registered herein should break or crack for as long as you own and reside in your house, Superior Metal Products LLC will furnish a replacement panel at no cost to the Warranty Holder except for shipping and handling charges, if applicable.

This warranty is limited to the furnishing of replacement insulated glass panels and does not cover or include any labor costs. Superior Metal Products LLC will not be responsible for any costs incurred in the removal or reinstallation of the insulated glass panels or window.

Additionally, this warranty does not cover damages resulting from improper installation, fire, flood, earthquake, lightning, ice, windstorms, hail, or other acts of God, wars, riots or civil unrest, vandalism or building settlement. This warranty is not applicable for products installed in non-owner multi-family occupied dwellings or used for commercial purposes such as schools, churches, government owned structures, office buildings, apartment buildings, condominiums, rental property, etc.

The warranties put forth in this certificate are only express warranties extended by Superior Metal Products LLC in connection with glass breakage. The remedies set forth in this certificate shall constitute the original homeowner's exclusive remedies, and Superior Metal Products LLC shall not be liable to the homeowner for incidental or consequential damages for the breach of any express or implied warranties in connection with the insulated glass panel or windows.

This limited warranty may not be changed or modified by any representative of the manufacturer or its distributors or dealers.

WARRANTY REGISTRATION AND CLAIMS

In order for the homeowner to be eligible for coverage under this warranty, the attached warranty registration card must be completed and signed by the original single family homeowner and the dealer that installed the windows covered by this warranty. The warranty registration card must be returned to Superior Metal Products LLC within thirty (30) days after completion of the installation. This warranty is limited to the original single family homeowner only and is not transferable.
